Buyer and Breeder agree to the following:

1. This contract refers to a registerable purebred Siberian cat/kitten sold as pet quality with limited registration unless otherwise noted in an addendum.
2. The cat is guaranteed to be of sound health upon arrival into Buyer's care. It will have been veterinarian checked preceding its departure from Snowy Kitten Siberians and on a cursory physical examination it will have been found to be free of internal and external parasites. It will have been vaccinated against Panleukopenia, Rhinotrachetitis and Calcinivirus. The Buyer will receive a health record from the Breeder's veterinarian as proof of examination, all vaccines received, as well as a schedule of the vaccines still needed to maintain the kitten's health in the future.
3. This cat is guaranteed against life-threatening HCM and PKD until its second birthday. Cats will be replaced upon receipt of diagnosis by a licensed veterinary specialist or necropsy conducted by licensed veterinary specialist, paid for by Buyer. Snowy Kitten Siberians will replace the affected kitten/cat with another of the same quality (pet / breeder / show). No cash refunds are provided. Except as stated in this contract, Breeder makes no representations as to the health or quality of this cat/kitten, nor does Breeder assume any other financial obligations to the Buyer.
4. The cat is guaranteed for a period of two weeks. This two-week period is deemed to start on the weekend that the breeder feels the cat can be released to its new home. The cat can be returned within this time period for any reason whatsoever for a refund of the purchase price, less \$150.00 as long as vaccines are up to date and health booklet is returned. Buyer agrees to return CFA or TICA registration to Breeder at time of return of kitten. Any and all vet bills or debts incurred on behalf of this cat/kitten as well as transportation costs to the Breeder are the sole responsibility of the Buyer.
5. Breeder is no longer responsible for the cat/kitten once it has been released to airline employees / or shipping agents of any kind; or owner. Additional insurance can be purchased through the airline.
6. Buyer agrees to follow seller's recommendations for transition period of two weeks to one month. Directions are provided at time of transfer of kitten. They include: isolation in a safe and cozy place, with climber, litter box, food and water to enable kitten to develop confidence and desire to explore and participate in its new life. Buyer agrees not to overwhelm kitten with other pets, visitors or too much handling. Kittens are like babies and need a gentle introduction to their new lives. Failure to follow instructions can lead to behaviour or emotional problems in your kitten. **Buyer initial:**_____

- 7. This cat/kitten will be kept indoors and not be allowed to roam freely outside. The only time it is permissible for the cat to be outdoors is when under supervision on a harness and leash or when protected within an approved cat enclosure or carrier.
- 8. Snowy Kitten Siberians kittens must never be declawed. Declawing surgically removes the tips of the cat's "fingers." Declawing is a mutilation and cruelty that can alter the kitten's/cat's temperament, behaviour, and health. **Declawing your kitten or cat voids all protections of this contract for the Buyer.** Buyer Initial: _____
- 9. Snowy Kitten Siberians must be contacted if, at any time during the cat's life, the buyer is unable to keep the cat. The Buyer agrees to give the Breeder a chance to re-house the cat. The Buyer also agrees that the cat will never be sold, given, leased out, rented, loaned to an animal shelter, pet store, commercial or private, laboratory or research and development center. If this cat is found to be neglected or mistreated, the buyer agrees to surrender the cat and all rights to the cat to the Breeder or her representative unconditionally without benefit of refund or any course of reclaim.
- 10. The Breeder will not be responsible for any veterinary expenses incurred by the Buyer while the cat is in the possession of the Buyer. The Buyer has read, understands and has signed the attached Addendum entitled, "A Special Note to Buyers Regarding Pedigree Cats". The total liability of the Breeder shall in no case exceed the total purchase price of the cat, less the cost of any medical procedures.
- 11. Because this cat's relatives will have been used in Snowy Kitten Siberians breeding program, the Breeder wishes to be notified of any health problems discovered in the purchased cat as it may have an impact on the health of related cats.
- 12. The Breeder has the right, at her discretion, to cancel this contract at any time before delivery of the cat. In this case, the full deposit will be returned to the Buyer. Should the Buyer cancel this agreement before the cat is delivered, or fail to pay the balance due on time, the cat may be sold to another and the Buyer's full deposit will be retained as a cancellation fee.

By signing this document, the contract and/or sales agreement, we, the Breeder and the Buyer, consider it to be legally binding under all circumstances and in all courts of law. This sales agreement is non-transferable to other parties. Any changes, additions, or omissions to this contract must be agreed upon in writing and dated and initialled by all parties. All legal expenses incurred by Snowy Kitten Siberians to enforce the terms of this contract will be paid by the Buyer and all legal action, whether it be started by the Buyer or the Breeder shall be conducted in Surrey, British Columbia, Canada, under the laws of the Province of British Columbia, Canada. If one clause in this contract is declared void, that does not affect the rest of the contract which shall remain valid.

This agreement is not to be superseded by any other agreement(s), be they written or verbal, unless accompanied with signed documentation outlining the new agreement or amendment.
